#### ATHLETIC OFFICIALS RATE INCREASE

Recommend that the Board approve the increase of the Athletic Officials rate increase. (EXHIBIT H)

Rates were not increased at the start of the school year. Refs want increases based on the Copper Country rates. Training for new local legacy refs is in progress, grant through the MHSAA is being used.

- -Instruction resources work; holding 2 meetings per month focusing on teacher needs, hands on training, textbook needs, etc.
- -Would like to schedule Board Retreat for Strategic planning work.

Superintendent Johson will create an agenda/priorities list to be discussed. Two meetings were scheduled for November 6 and December 4, 2024.

## Assistant Principal Uotila:

- -Discipline referrals are down by 280% from September, does not include attendance write ups.
- -There have been 3 positive behavior entries.
- -Homecoming was a great success, student participation was high in all grades. The engagement was exciting to see. The Powderpuff game went great.
- -Trips are set up for welding students to visit AWI and Michigan Tech CEGE (Civil, Environmental and Geospatial Engineering Department.
- -Morale is good. Teachers and staff are doing a great job being involved both in and out of the classroom.
- -Great interest for the Robotics team this year.
