#### **CTE BUILDING**

Recommend that the board of education accept the resolution for the purchase of the CTE building by the ISD. (EXHIBIT C)
Ashley Nevins of the ISD was present to give an update about the ISD history and future.

The ISD was placed in charge of a \$30 million dollar grant by the State of Michigan to oversee the expenditures.

The ISD Board reviewed potential areas to use the funds with a specific focus on CTE. Due to making a substantial investment in the CTE building, they would like to have ownership of the building. Engineering is in progress, the budget will be based upon the work that needs to be done and phased over years to avoid classroom disruption. Would like to add Building Trades back into the curriculum as early as fall of 2025.

There may need to be some additional changes to the purchase agreement. In the event that there would be no CTE classes, the building would revert back to OASD.

Mattson made a motion, supported by Weisinger, to approve the resolution.

#### Superintendent Johnson reported:

- -Facilities Updates: Gym floor will be redone over break.
- -Teaching & Learning: Mid Year assessments in progress, math instruction and intervention training continues.

Elementary -Social & Emotional: Bi-weekly meetings occurring with teams, social worker is close to capacity and small work groups are being held.

- -Legislative updates: Many bills in the works with lamb duck session. Watching closely over the next bit of time. Some items include: Insurance Hard Cap bill moving forward that will adjust the hard cap going forward, FAFSA application bill requirement for graduation. Mandatory Kindergarten bill. HB5649 requires public high schools to offer a computer science course without adding a graduation requirement. Other updates include school security, pension changes, firearm safety, first aid health education requirement, disclosure and transparency modifications, organ tissue donation required curriculum, etc.
- -Updated budget will be provided at that January meeting.
