Superintendent Johnson reported:



- Budget: Need to begin the process internally and post open or potential open positions for next year.
- PD - Staff 2/14/25: Elementary focused on math resources and small group instruction. Secondary focus was on disciplinary literacy.
- Student Teacher: Will have a student teacher from NMU on site in the fall for 3rd grade.
- German Trip: 8 students confirmed, many still thinking about it, depending on the final number we may need to add a male staff chaperone. Final decision will be made next week to hold the trip in April 2026.
- Athletics: Boys Basketball district tournaments will be held here next week. Girls Softball collaborative team name and colors are being decided upon.
